## Updated Government Gazettes listing dual use controlled goods: South African Council for the Non-Proliferation of Weapons of Mass Destruction

The South African Council for the Non-Proliferation of Weapons of Mass Destruction (the Council) would like to inform all relevant industry stakeholders that the Council has updated five Government Gazettes promulgated under the Non-Proliferation of Weapons of Mass Destruction Act, 1993 (Act No.87 of 1993) (Non-Proliferation Act).

The Council is a statutory body established in terms of the Non-Proliferation Act to regulate strategic (dual use) goods and technologies that could be used in the development and production of weapons of mass destruction. As contemplated in the Non-Proliferation Act, the Minister of Trade, Industry and Competition may make regulations regarding the application of the provisions of international conventions, treaties and agreements with regard to non-proliferation entered into or ratified by the Government of the Republic. On 14 June 2024, the Minister signed the below mentioned Government Gazettes, which has repealed the Government Notices that were signed on March 2019 and April 2021.
